**ORDER GRANTING TRUSTEE'S MOTION TO COMPEL PRODUCTION OF DOCUMENTS FROM ARTHUR MARK FEUERBORN**

**THIS MATTER** having come before the Court on the 21<sup>st</sup> day of October, 2015 at 9:30 a.m., in West Palm Beach, Florida, upon the *Trustee's Motion to Compel Production of Documents From Arthur Mark Feuerborn* (the "Motion") [ECF No. 1193]. The Court, having considered the Motion and the argument of counsel, having considered the *Affidavit of Leslie Gern Cloyd as to Attorneys' Fees Expended With Respect to Arthur Mark Feuerborn* [ECF No. 1211] (the "Affidavit") filed on October 27, 2015, having determined that the hourly rates and time spent, as set forth in the Affidavit, are reasonable, and being otherwise fully advised in the

premises, does thereupon

**ORDER** as follows:

1. The Motion is **GRANTED**.
2. Arthur Mark Feuerborn (“Feuerborn”) shall have seven (7) days from the date of this Order to produce all remaining documents not previously produced, in compliance with the Subpoena attached to the Motion as Exhibit “A,” including, but not limited to, all documents relating to payments and/or transfers of funds relating to Mr. Feuerborn’s representation of Collingwood (as such term is defined in the Subpoena attached to the Motion as Exhibit “A”).
3. Feuerborn shall have seven (7) days from the date of this Order to produce a privilege log, or any privileges are deemed waived.
4. The Trustee, Deborah C. Menotte (the “Trustee”), is awarded reasonable attorneys’ fees in the amount of \$4,367.00, representing the fees expended by Berger Singerman LLP on behalf of the Trustee in connection with the efforts to obtain the remaining documents from Feuerborn.
5. Feuerborn is directed to pay the sum of \$4,367.00 to Deborah C. Menotte, Trustee, so as to be received within fourteen (14) days from the entry of this Order, and shall mail such payment to the Trustee at the following address: Deborah C. Menotte, Trustee, P.O. Box 211087, West Palm Beach, FL 33421.
