ORDER TO SHOW CAUSE DIRECTED TO THE LAW OFFICES OF ARTHUR MARK FEUERBORN & ASSOCIATES AND ARTHUR MARK FEUERBORN

THIS MATTER came before the Court on the 2nd day of December, 2015 at 9:30 a.m., in West Palm Beach, Florida, upon the *Trustee's Motion for an Order to Show Cause Against Law Offices of Arthur Mark Feuerborn & Associates and Arthur Mark Feuerborn* [ECF No. 1225] (the "Motion for Order to Show Cause") filed by the Trustee, Deborah C. Menotte (the "Trustee"). In the Motion for Order to Show Cause, the Trustee seeks the entry of an order directing the Law Offices of Arthur Mark Feuerborn & Associates and Arthur Mark Feuerborn to show cause why they should not be held in contempt of court for failing to comply with the Court's *Order Granting Trustee's Motion to Compel Production of Documents From Arthur*

Mark Feuerborn [ECF No. 1216] dated October 30, 2015 (the “Order Granting Motion to Compel”). The Motion for Order to Show Cause further seeks the entry of an order directing the Law Offices of Arthur Mark Feuerborn & Associates and Arthur Mark Feuerborn to pay the Trustee’s attorneys’ fees and costs in addressing the non-compliance by the Law Offices of Arthur Mark Feuerborn & Associates and Arthur Mark Feuerborn. The Court, having considered the Motion for Order to Show Cause and the *Affidavit of Leslie Gern Cloyd as to Attorneys’ Fees Expended With Respect to the Arthur Mark Feuerborn* [ECF No. 1244], finding good cause for the granting of the Motion for Order to Show Cause, and being otherwise fully advised in the, does thereupon

ORDER as follows:

1. The Motion for Order to Show Cause is **GRANTED**.
2. The Trustee is awarded reasonable attorneys’ fees in the amount of \$4,736.00, (which sum is in addition to the \$4,367.00 awarded to the Trustee by the Order Granting Motion to Compel dated October 30, 2015 [ECF No. 1216]), representing the fees expended by Berger Singerman LLP on behalf of the Trustee in connection with the Motion for Order to Show Cause.
3. The Law Offices of Arthur Mark Feuerborn and Arthur Mark Feuerborn are directed to pay the sum of \$4,736.00 to Deborah C. Menotte, Trustee, so as to be received within fourteen (14) days from the entry of this Order, and shall mail such payment to the Trustee at the following address: Deborah C. Menotte, Trustee, P.O. Box 211087, West Palm Beach, FL 33421.
4. A duly authorized corporate representative of the Law Offices of Arthur Mark Feuerborn & Associates, and Arthur Mark Feuerborn shall appear at a hearing on **January 6,**

2016 at 9:30 a.m. before the Honorable Erik P. Kimball at the United States Bankruptcy Court, Flagler Waterview Building, 1515 North Flagler Drive, 8th Floor, West Palm Beach, FL 33401, to show cause why the Law Offices of Arthur Mark Feuerborn & Associates and Arthur Mark Feuerborn should not be held in contempt of court for the failure to comply with this Court's Order Granting Motion to Compel, and should not be subject to additional sanctions.
