**ORDER ON ORDER TO SHOW CAUSE DIRECTED TO THE LAW OFFICES OF
ARTHUR MARK FEUERBORN & ASSOCIATES AND ARTHUR MARK FEUERBORN**

THIS MATTER came before the Court on the 21st day of January 2016 at 9:30 a.m., in West Palm Beach, Florida, upon the continued hearing on this Court's *Order to Show Cause Directed to the Law Offices of Arthur Mark Feuerborn & Associates and Arthur Mark Feuerborn* [ECF No. 1250] (the "Show Cause Order") dated December 11, 2015. The Court, having considered the argument of counsel, having noted that the Law Offices of Arthur Mark Feuerborn & Associates and Arthur Mark Feuerborn (collectively, "Feuerborn") failed to file a formal response; having been advised that Feuerborn failed to pay the sum of \$4,736.00 to the

Trustee, Deborah C. Menotte (“Trustee”), as directed by the Show Cause Order, and being otherwise fully advised in the premises, does thereupon

ORDER as follows:

1. Feuerborn is directed to produce, within seven (7) days from the date of this Order, all documents during the period of January 1, 2010 to the present, in response to the *Subpoena For Rule 2004 Examination Duces Tecum* dated July 31, 2015, and attached as Exhibit “A” to the *Trustee’s Motion for an Order to Show Cause Against Law Offices of Arthur Mark Feuerborn & Associates, and Arthur Mark Feuerborn* (the “Subpoena”), which documents shall be unredacted, and shall include, but not be limited to:

a. All bank account records relating in any way to any transactions involving Sunstar and/or Collingwood (as such terms are defined in the Subpoena);

b. All escrow agreements relating to Sunstar Financial, LLC (“Sunstar”) and/or Reed Collingwood (“Collingwood”), including any and all agents, employees, servants, officers, directors, attorneys and all other persons or entities acting or purporting to act on behalf of Sunstar and/or Collingwood, or any other entity or person under the direct control of Sunstar or Collingwood;

c. All trust account ledgers reflecting any monies deposited into or transferred out of trust relating in any way to Sunstar and/or Collingwood (as such terms are defined in the Subpoena);

d. All electronic mail transmissions, and correspondence, including any correspondence received by Feuerborn by any third party, that relate in any way to Sunstar or Collingwood (as such terms are defined in the Subpoena);

e. All documents evidencing all wire transfers sent from any account in the name of Feuerborn that relate in any way to Sunstar or Collingwood (as such terms are defined in the Subpoena);

f. All documents relating to any business transactions that relate to Sunstar or Collingwood (as such terms are defined in the Subpoena);

g. Any and all other documents that relate to Sunstar or Collingwood (as such terms are defined in the Subpoena).
