ORDER GRANTING TRUSTEE’S CORRECTED OMNIBUS MOTION TO APPROVE SETTLEMENT BETWEEN DEBORAH C. MENOTTE, TRUSTEE AND MAATSCHAP QI COLLECTIEF REGARDING BGI FUND CLAIMS

THIS MATTER came before the Court for hearing on the 15th day of August, 2019 at 9:30 a.m. in West Palm Beach, Florida upon the *Trustee’s Corrected Omnibus Motion to Approve Settlement Between Deborah C. Menotte, Trustee and Maatschap QI Collectief Regarding BGI Fund Claims* (the “Motion”) [ECF No. 1808]. The Motion requests entry of an order approving a settlement between the Trustee¹ and the MQIC BGI Claimants compromising the MQIC BGI

Claims. The Court finds that (i) it has jurisdiction over the matters raised in the Motion pursuant to 28 U.S.C. §§ 157 and 1334; (ii) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and that this Court may enter a final order consistent with Article III of the United States Constitution; (iii) venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; (iv) the relief requested in the Motion is in the best interests of the Debtors, its estate, their creditors and other parties in interest; (v) notice of the Motion and the hearing thereon was appropriate under the circumstances and no other notice need be provided; and (vi) upon a review of the record before the Court, including the legal and factual bases set forth in the Motion, good and sufficient cause exists for the granting of the relief as set forth herein, and being otherwise fully advised in the premises, the Court **ORDERS** as follows:

1. The Motion is **GRANTED**.
2. The Court **APPROVES** the compromise and disposition of the MQIC BGI Claims as reflected in Exhibits A and B hereto, and the MQIC BGI Claims shall be treated as set forth in the column entitled “Disposition of Claim” on the attached Exhibits A and B.
3. The Court retains jurisdiction to interpret and enforce the terms of the MQIC Settlement.
