**ORDER OF JOINT ADMINISTRATION OF  
RELATED CASES WITH CLSF III IV, INC. AS LEAD CASE**

This matter came before the Court for hearing on Thursday, December 6, 2012 at

1:30 p.m. (the "Hearing"), upon Creditor, Maatschap QI Collectief's ("MQIC"), motion seeking joint administration of the above captioned cases (the "Motion"), and upon the objection filed by Deborah Menotte, as Chapter 7 Trustee (the "Objection"). The Motion was filed pursuant to 11 U.S.C. § 105, Rules 1015(b) and 2009 of the Federal Rules of Bankruptcy Procedure, and Rule 1015-1 of the local rules for the United States Bankruptcy Court for the Southern District of Florida. The Court heard argument of counsel at the Hearing, reviewed the Motion, and finds that joint administration of these cases is proper and in the best interests of the estates and of their creditors. Accordingly, the Court **ORDERS** as follows:

1. The Motion is granted
2. The Objection is overruled.
3. The above captioned cases shall be jointly administered with the case of CLSF III IV, Inc., Case No. 12-30081-BKC-EPK, designated as the "Lead Case."
4. A single case docket and court file will be maintained hereafter under the Lead Case number, 12-30081-BKC-EPK.

Pleadings filed in other than the Lead Case shall be captioned under the Lead Case names and case number followed by the words “(Jointly Administered)” and beneath that caption, the case names and numbers for the cases in which the document is being filed. Claims filed shall indicate only the case name and number of the case in which the claim is asserted. Separate claims registers shall be maintained for each case.
