**ORDER CANCELLING HEARING ON MOTION FOR SUBSTANTIVE  
CONSOLIDATION AND SETTING PRELIMINARY HEARING**

THIS MATTER came before the Court upon *MQIC's Motion (I) For Derivative Standing to File Motion for Substantive Consolidation and (II) For Substantive Consolidation of the Jointly Administered Ponzi Entities' Bankruptcy Estates, Related Florida Trusts, and Deborah C. Peck, P.A.* [ECF No. 196] (the "Motion") filed by Maatschap QI Collectief ("MQIC").

The Motion was originally self-calendared for hearing on February 21, 2013 by MQIC. Having reviewed the Motion, and being otherwise fully advised in the premises, it is **ORDERED** that:

1. The February 21, 2013 hearing on the Motion [ECF No. 196] is CANCELLED.
2. The Court will hold a non-evidentiary preliminary hearing (the "Preliminary Hearing") on the Motion [ECF No. 196] on April 11, 2013 at 1:30 p.m. at the United States Bankruptcy Court, Courtroom B, 8th Floor, 1515 North Flagler Drive, West Palm Beach, Florida 33401.
3. At the Preliminary Hearing, the Court will: (a) schedule an evidentiary hearing on the Motion [ECF No. 196], if necessary; (b) determine issues to be addressed at such evidentiary hearing; and (c) address pre-evidentiary hearing briefing.
4. The parties are directed to refrain from filing briefs and/or memoranda as to the Motion [ECF No. 196] until after the April 11, 2013 hearing.
