Chapter 7

**ORDER SETTING DEADLINE TO FILE  
NON-GOVERNMENTAL PROOFS OF CLAIM**

THIS MATTER came before the Court *sua sponte*.

The original deadlines for filing non-governmental proofs of claim in the above-captioned cases varied, but each has since passed. On February 7, 2013, Maatschap QI Collectief (“MQIC”) filed *MQIC’s Motion (I) for Derivative Standing to File Motion for Substantive Consolidation, and (II) for Substantive Consolidation of the Jointly Administered Ponzi Entities’ Bankruptcy Estates, Related Florida Trusts, and Deborah C. Peck, P.A.* [ECF No. 196] (the “Original Motion for Substantive Consolidation”). Before each of the original deadlines for filing non-governmental proofs of claim passed, MQIC and Stichting Participantenbelangen QI (“SPQI”) filed *MQIC and SPQI’s Joint Unopposed Omnibus Motion to Extend Claims Bar Dates in All Jointly Administered Cases* [Case No. 12-30081-EPK, ECF No. 291] (the “Motion for Substantive Consolidation”). On March 21, 2013, the Court entered its *Order Granting MQIC and SPQI’s Joint Unopposed Omnibus Motion to Extend Claims Bar Dates in All Jointly Administered Cases* [ECF No. 327] (the “Bar Date Extension Order”). In the Bar Date Extension Order, the Court extended the deadline to file non-governmental proofs of claim in each of the above-captioned cases to 120 days from the date of the Court’s ruling on the Original Motion for Substantive Consolidation. On May 6, 2013, the Court entered its *Order Setting Further Status Conference, Objection Deadline, and Evidentiary Hearing Dates Related to MQIC’s Motion (I) for Derivative Standing to File Motion for Substantive Consolidation, and (II) for Substantive Consolidation of the Jointly Administered Estates* [ECF No. 349], in which the Court set an evidentiary hearing on the Motion for Substantive Consolidation for July 8, 9, and 12, 2013. Subsequently, MQIC filed *MQIC’s Amended Motion (I) for Derivative Standing to File Motion for Substantive Consolidation, and (II) for Substantive Consolidation of the Jointly Administered Bankruptcy Estates* [Case No. 12-30081-EPK, ECF No. 358] on May 9, 2013

(the “Amended Motion for Substantive Consolidation”), thereby replacing the Motion for Substantive Consolidation. Thus, the deadline for filing non-governmental proofs of claim in each of the above-captioned cases was extended to 120 days after the Court’s prospective ruling on the Amended Motion for Substantive Consolidation. However, on June 13, 2013, MQIC withdrew the Amended Motion for Substantive Consolidation and the July evidentiary hearing on that motion never occurred.

On July 23, 2013, Chapter 7 Trustee Deborah C. Menotte (the “Trustee”) filed the *Trustee’s Amended Motion for Substantive Consolidation of the Jointly Administered Bankruptcy Estates and Memorandum of Law in Support* [ECF No. 415] (the “Trustee’s Motion for Substantive Consolidation”). The Court has entered a separate order scheduling the Trustee’s Motion for Substantive Consolidation for hearing on September 23 and 24, 2013.

Given the foregoing facts, and being otherwise fully advised in the premises, the Court finds it appropriate to extend the deadline for parties to file non-governmental proofs of claim in each of the above-captioned cases to 120 days after the Court enters its ruling on the Trustee’s Motion for Substantive Consolidation.

Therefore, it is **ORDERED AND ADJUDGED** that the deadline for parties to file non-governmental proofs of claim in each of the above-captioned cases is hereby **EXTENDED** to 120 days after the Court enters its ruling on the Trustee’s Motion for Substantive Consolidation [ECF No. 409].
