**TRUSTEE’S MOTION TO APPROVE MEDIATED SETTLEMENT AGREEMENT
BETWEEN (I) DEBORAH C. MENOTTE, TRUSTEE; (II) LIFETIME SETTLEMENTS,
INC.; (III) LIFETIME LEGACIES, INC.; AND (IV) 3825892 CANADA, INC., WITH
RESPECT TO ADVERSARY NO.: 13-01328-EPK**

Any interested party who fails to file and serve a written response to this motion within 21 days after the date of service stated in this motion shall, pursuant to Local Rule 9013-1(D), be deemed to have consented to the entry of an order in the form attached to this motion. Any scheduled hearing may then be canceled.

Deborah C. Menotte, the duly appointed and acting Chapter 7 Trustee (the “Trustee”) for the bankruptcy estates of CLSF III IV, Inc., *et al.* (collectively, the “Debtors”), by and through undersigned counsel, files this *Trustee’s Motion to Approve Mediated Settlement Agreement Between (I) Deborah C. Menotte, Trustee; (II) Lifetime Settlements, Inc.; (III) Lifetime Legacies, Inc.; and (IV) 3825892 Canada, Inc., With Respect to Adversary No.: 13-01328-EPK* (the “Motion”), pursuant to Rule 9019 of the Federal Rules of Bankruptcy Procedure, seeking approval of a compromise and settlement between (i) the Trustee; (ii) Lifetime Settlements, Inc.; (iii) Lifetime Legacies, Inc.; and (iv) 3825892 Canada, Inc. (collectively, with the Trustee, “the Parties”), and in support states:

Background

1. On August 22, 2012 (the “Petition Date”), the above-captioned bankruptcy case was commenced by the filing of an involuntary petition for relief in this Court under Chapter 7 of the Bankruptcy Code.

2. Deborah C. Menotte is the duly appointed and acting Chapter 7 Trustee of the Debtors’ estates.

3. On April 24, 2013, the Trustee commenced an adversary proceeding by the filing of a *Complaint to Avoid and Recover Fraudulent Transfers, for Turnover, and for a Preliminary Injunction and Permanent Injunction* (the “Complaint”) against Lifetime Settlements, Inc., John G. MacKay and Lorraine M. MacKay, thereby initiating Adversary No. 13-1328-EPK (the “Adversary Proceeding”).

4. On June 28, 2013, the Plaintiff filed an *Amended Complaint to Avoid and Recover Fraudulent Transfers, for Turnover, and for a Preliminary Injunction and Permanent Injunction* [ECF No. 30] (the “Amended Complaint), thereby adding additional defendants, Berkshire Settlements, Inc. (“Berkshire”), Lifetime Legacies, Inc. and 3825892 Canada, Inc.

5. On July 15, 2013, the Plaintiff dismissed Defendants, John G. MacKay and Lorraine M. MacKay by the filing of a *Notice of Voluntary Dismissal, Without Prejudice, as to Defendants, John G. MacKay and Lorraine M. MacKay* [ECF No. 43].

6. On October 2, 2013, the Court entered an *Order Granting Trustee’s Second Amended Motion for Substantive Consolidation of the Jointly Administered Bankruptcy Estates* [ECF No. 561] (the “SubCon Order”), which granted the substantive consolidation of the bankruptcy estate of the Debtor with that of its affiliated debtors, seventy-four other non-debtor entities (the “Non-Debtor Entities”).

7. The Plaintiff previously resolved its disputes with Berkshire, and entered into a

separate settlement agreement which was approved by the Court by Order dated September 24, 2013 [ECF No. 540].

8. The Complaint alleges that CLSF XXXIX, Inc., one of the Non-Debtor Entities, transferred a life insurance policy (Policy Number XXXX-4747) (the “Policy”) to Lifetime Settlements, Inc., which Policy was issued by Phoenix Life Insurance Company in the face amount of \$5,000,000.00 on the life of Morris Gluck. Subsequently, the beneficiaries were changed to include Lifetime Settlements, Inc., Lifetime Legacies, Inc. and 3825892 Canada, Inc.

9. Pursuant to the Court’s *Order of Referral to Mediation* [ECF No. 107] entered in the Adversary Proceeding, the Court ordered the Parties to participate in mediation, and the mediation was conducted on March 31, 2014.

Settlement and Compromise

10. The mediation conducted on March 31, 2014 resulted in a settlement and the Parties have entered into a *Mediated Settlement Agreement* (the “Settlement Agreement”), a copy of which is attached hereto as **Exhibit “A”** and is subject to the approval of this Court after notice and hearing.

11. Through this Motion, the Parties seek to resolve the Adversary Proceeding and all other disputes between them, upon the following terms and conditions as set forth in the Settlement Agreement:¹

a. **Payment of Money.** Lifetime Settlements, Inc., Lifetime Legacies, Inc. and 3825892 Canada, Inc. (collectively, the “Defendant”) shall pay Five Hundred Twenty Five Thousand Dollars (\$525,000) (the “Funds”) to the Trustee by wire transfer to be received by Trustee’s counsel no later than June 30, 2014.

¹In the event of any inconsistency between the description of the Settlement Agreement in the body of this motion, and the Settlement Agreement itself, attached as Exhibit A, the terms of the Settlement Agreement shall control.

b. Payment of Premium. Defendant shall timely pay all Policy premiums until payment of the Funds and shall take all action reasonably necessary to ensure continuation of the Policy through payment of the Funds.

c. Maturity of Policy. Notwithstanding anything to the contrary set forth in the Settlement Agreement, in the event the Policy matures before receipt by Trustee of the Funds, Trustee shall receive 100% of the Policy's death benefit (\$5,000,000) and shall pay to Defendant the following amount from the proceeds of the Policy, within 30 days after receipt by Plaintiff of the death benefit:

- i. \$1,000,000; and
- ii. \$365,000 paid by Defendant for the Policy; and
- iii. All Policy premiums paid by Defendant after its acquisition of the Policy which Defendant and Trustee estimate is approximately \$381,430 as of March 31, 2014, but which amount may increase by Policy premiums made by Defendant after March 31, 2014.

12. No Default. Upon satisfaction by Defendant with all obligations under Paragraphs 1 and 2 of the Settlement Agreement:

a. The Trustee shall dismiss the Adversary Proceeding with prejudice and shall disclaim all interest in the Policy, except as set forth in the Settlement Agreement;

b. Trustee shall release Defendant, their officers, directors, shareholders, John Mackay and Lorraine Mackay, from any and all claims, causes of action, whether known or unknown, foreseen or unforeseen, due or not due, contingent or fixed, matured or unmatured, relating in any way to the Adversary Proceeding or claims that were or could have been made in the Adversary Proceeding.

c. Defendant shall release the Trustee from any and all claims, causes of action, whether known or unknown, foreseen or unforeseen, due or not due, contingent or fixed, matured or unmatured, relating in any way to the Adversary Proceeding or claims that were or could have been made in the Adversary Proceeding.

13. Default. In the event Defendant fails to satisfy its obligations under Paragraphs 1 or 2 of this Agreement:

a. Defendant shall immediately transfer the Policy to the Trustee;

b. The Trustee shall market and sell the Policy and shall pay to Defendant from the net proceeds of sale,

i. All Policy premiums paid by Defendant after March 31, 2014; and

ii. \$100,000.

14. Bankruptcy Court Approval. The Trustee's obligations under the Settlement Agreement shall be subject to approval of the Court. The Trustee shall file a motion for approval of the Settlement Agreement with the Court no later than April 5, 2014.

a. The Trustee and Defendant shall jointly request that the April 10, 2014 pre-trial conference scheduled in connection with the Adversary Proceeding be continued for a period of sixty days to allow time for the Court to consider approval of the Settlement Agreement.

15. Miscellaneous. The Settlement Agreement constitutes the entire agreement between the Parties. The Settlement Agreement shall be construed in accordance with Florida law. The Court shall retain exclusive jurisdiction to interpret and enforce the Settlement Agreement.

Legal Analysis

16. The Trustee seeks approval of the Settlement Agreement pursuant to Rule 9019 of the Federal Rules of Bankruptcy Procedure.

17. Rule 9019(a) provides that, after notice and a hearing, a court may approve a proposed settlement of a claim. The decision of whether or not to approve a compromise is within the sound discretion of the court. *In re Carson*, 82 B.R. 847 (Bankr. S.D. Ohio 1987); *In re Mobile Air Drilling Co.*, 53 B.R. 605 (Bankr. N.D. Ohio 1985).

18. In passing on proposed settlements, the standard that courts applied under the former Bankruptcy Act is the same standard as courts should apply under the Bankruptcy Code. *In re Carla Leather, Inc.*, 44 B.R. 457, 466 (Bankr. S.D.N.Y. 1984). As stated by the United States Supreme Court in *Protective Committee v. Anderson*, 300 U.S. 414 (1968), under the Act, to approve a proposed settlement, a court must find that the settlement was “fair and equitable” based on an educated estimate of the complexity, expense, and likely duration of . . . litigation, the possible difficulties of collecting on any judgment which might be obtained and all other factors relevant to a full and fair assessment of the wisdom of the proposed compromise. *Protective Committee*, 300 U.S. at 424.

19. This test was adopted by the Eleventh Circuit in *In re Justice Oaks II, Ltd.*, 898 F.2d 1544, 1549 (11th Cir. 1990), which provides additional guidance as to whether a compromise should be approved. *Justice Oaks* established a four-part test for approval:

- (a) The probability of success in litigation;
- (b) The difficulties, if any, to be encountered in the matter of collection;
- (c) The complexity of the litigation involved and the expense, inconvenience and delay necessarily attending it; and

(d) The paramount interest of the creditors and a proper deference to their reasonable views in the premises.

20. The Settlement Agreement satisfies the *Justice Oaks* standard.

21. Applying the foregoing, the terms of the Settlement Agreement satisfy that four-part test relating to the Rule 9019 request. The Trustee believes that notwithstanding the likelihood of success in potential litigation, the expense, inconvenience and delay that would be caused by litigating and the uncertainty of the collection of the monies owed would not be in the best interests of the Debtor's estate. Therefore, it is the belief of the Trustee that after full and careful consideration of the merits of the Trustee's claims, settlement of the claims pursuant to the terms set forth herein and in the Settlement Agreement would be in the best interests of the Debtors' estates.

22. Additionally, counsel for the Trustee is mindful of the additional administrative expenses that will be incurred in the event that the Settlement Agreement is not approved. The Trustee believes that resolution of the above-referenced matters in the manner set forth herein and in the Settlement Agreement is reasonable and falls well within the range of reasonableness as required by Rule 9019 of the Federal Rules of Bankruptcy Procedure and applicable law.

WHEREFORE, the Trustee respectfully requests that this Court enter an Order in the form attached hereto as **Exhibit "B"**:

- a. Granting this Motion;
- b. Approving the Settlement Agreement in its entirety, in the event that no written objections are filed within the time prescribed by Local Rule 9013-1(D); and
- c. Granting such other and further relief as the Court deems just and proper.

This SETTLEMENT AGREEMENT (this "Agreement") is dated this 31st day of March, 2014 by and among Deborah C. Menotte, not individually but as trustee of CLSF III IV, Inc., et al (the "Plaintiff") and Lifetime Settlements, Inc., a Delaware corporation, Lifetime Legacies, Inc., an Ontario corporation and 3825892, a Canadian federal corporation (collectively, "Defendant").

RECITALS

WHEREAS, Plaintiff and Defendant are parties to litigation captioned Menotte v. Lifetime Settlements, Inc., et al and pending as case number 13-01328-EPK (the "Case") in the United States Bankruptcy Court for the Southern District of Florida (the "Court");

WHEREAS, the Case involves life insurance policy No. XXX-4747, issued by Phoenix Life Insurance Company insuring the life of Morris Gluck (the "Policy");

WHEREAS, Plaintiff and Defendant participated in a mediation on March 31, 2014, which resulted in the execution and delivery of this Agreement;

WHEREAS, to avoid the time, expense and uncertainty of litigation, Plaintiff and Defendant desire to settle the Case on the terms set forth in this Agreement.

NOW, THEREFORE, in consideration of the recitals herein before stated and the mutual representations, warranties, covenants and agreements hereinafter set forth, the receipt and sufficiency of which are hereby acknowledged, Plaintiff and Defendant do hereby covenant and agree as follows:

AGREEMENT

1. Payment of Money. Defendant shall pay Five Hundred twenty Five Thousand Dollars (\$525,000) (the "Funds") to Plaintiff by wire transfer to be received by Plaintiff's counsel no later than June 30, 2014.
2. Payment of Premium. Defendant shall timely pay all Policy premiums until payment of the Funds and shall take all action reasonably necessary to ensure continuation of the Policy through payment of the Funds.
3. Maturity of Policy. Notwithstanding anything to the contrary set forth in this Agreement, in the event the Policy matures before receipt by Plaintiff of the Funds, Plaintiff shall receive 100% of the Policy's death benefit (\$5,000,000) and shall pay to Defendant the following amount from the proceeds of the Policy, within 30 days after receipt by Plaintiff of the death benefit:
 - 3.1. \$1,000,000; and
 - 3.2. \$365,000 paid by Defendant for the Policy; and
 - 3.3. All Policy premiums paid by Defendant after its acquisition of the Policy which Defendant and Plaintiff estimate is approximately \$381,430 as of March 31, 2014, but which amount may increase by Policy premiums made by Defendant after March 31, 2014.

4. No Default. Upon satisfaction by Defendant with all obligations under Paragraphs 1 and 2 of this Agreement:
 - 4.1. The Plaintiff shall dismiss the Case with prejudice and shall disclaim all interest in the Policy, except as set forth in this Agreement;
 - 4.2. Plaintiff shall release Defendant, their officers, directors, shareholders, John Mackay and Lorraine Mackay, from any and all claims, causes of action, whether know or unknown, foreseen or unforeseen, due or not due, contingent or fixed, matured or unmatured, relating in any way to the Case or claims that were or could have been made in the Case.
 - 4.3. Defendant shall release Plaintiff from any and all claims, causes of action, whether known or unknown, foreseen or unforeseen, due or not due, contingent or fixed, matured or unmatured, relating in any way to the Case or claims that were or could have been made in the Case.
5. Default. In the event Defendant fails to satisfy its obligations under Paragraphs 1 or 2 of this Agreement:
 - 5.1. Defendant shall immediately transfer the Policy to Plaintiff;
 - 5.2. Plaintiff shall market and sell the Policy and shall pay to Defendant from the net proceeds of sale,
 - 5.2.1. All Policy premiums paid by Defendant after March 31, 2014; and
 - 5.2.2. \$100,000.
6. Bankruptcy Court Approval.
 - 6.1. Plaintiff's obligations under this Agreement shall be subject to approval of the Court. Plaintiff shall file a motion for approval of this Agreement with the Court no later than April 5, 2014.
 - 6.2. Plaintiff and Defendant shall jointly request that the April 10, 2014 pre-trial conference scheduled in connection with the Case be continued for a period of sixty days to allow time for the Court to consider approval of this Agreement.
7. Miscellaneous. This Agreement constitutes the entire agreement between the parties. This Agreement shall be construed in accordance with Florida law. The Court shall retain exclusive jurisdiction to interpret and enforce this Agreement.
