estates and is a disinterested person as required by 11 U.S.C. § 327(a), having considered the argument of counsel, and being otherwise fully advised in the premises, does thereupon

ORDER that:

1. The Application is **APPROVED.**

2. The employment by the Trustee of KapilaMukamal, as accountant and financial advisor to the Trustee, is **APPROVED**, pursuant to 11 U.S.C. § 327(a), *nunc pro tunc* to May 1, 2014.

3. KapilaMukamal LLP shall apply for compensation and reimbursement of costs, pursuant to 11 U.S.C. §§ 330 and 331, at its ordinary rates, as they may be adjusted from time to time, for services rendered and costs incurred as accountant and financial advisor to the Trustee. KapilaMukamal will apply for compensation and reimbursement of costs.

4. This Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation of this Order.
